

DIRECTOR FIT & PROPER POLICY

Introduction

The Nominating Committee ("NC") of Tek Seng Holdings Bhd (the "Company" or "Tek Seng"), has adopted the following policy with regard to ascertaining the fit and proper criteria at the time of appointment of Directors and on a continuing basis.

The Committee may review the policy on a periodic basis and may amend this policy from time to time, if required.

This policy will be applicable to the Company and is aimed at laying down guidelines to be followed at the time of appointment of Directors as also on an ongoing basis for the existing Directors of the Company.

Objective

This Policy sets out the fit and proper criteria for the appointment and re-appointment of Directors on the Board of the Company.

- To ensure that each of the Directors has the character, experience, integrity, competence and time to effectively discharge his/her role as a Director of The Company.
- To ensure that existing and new Directors of the Company are fit and proper as well as appropriate for the position to which they may be appointed; and continue to be fit and proper while they hold their position.

Guidelines on the "Fit and Proper" criteria

The Committee shall ensure that prior to considering any candidate for appointment, reappointment as a Director on the Board of the Company, detailed to consider suitability of the candidate such as:

- Qualification
- Expertise and competence
- Financial integrity
- Reputation and character
- Any other parameters that the Committee may deem fit to analyze

A declaration in the format as provided in Appendix 1 to this policy, shall be obtained from candidates being considered for appointment, re-appointment as Directors of the Company. The Committee shall scrutinize the declarations and the chairperson of the Committee may thereafter add remarks on the declaration.

Modifications to this policy

Any modifications to this policy shall be necessarily approved by the Committee.
